1. General Guidelines

Word Count: Please limit manuscript word count to 10,000 words.

Font: lower case Times new roman.

Size 12pt. Interval 12 pt. Alignment: complete.

The first page of the document should include the following:

- **Title of Article:** Capital times new roman, 14pt., bold, complete alignment.
- **Author's full name** (below the title in lowercase times new roman 14pt., bold, right alignment).
- **For those who are not faculty members or researchers:** Degree, specialty or profession, employee position or affiliation (12pt., lowercase, right alignment): e.g. Dr. in Criminology, Sociologist, Democritus University of Thrace / Dr. in Penal Law, Post-Doc Researcher, Univ. of the Aegean / Dr. Of Law, Criminologist, Lawyer / Msc. In Criminology, Rodopi Juvenile Probation Service.
- **Faculty members or Researchers:** Degree, Scientific area, Department, University.
- **Article Abstract** 100-150 words in Greek and in English (12pt., lowercase in complete alignment).

Attention: Only one specialty and one degree should be mentioned in the author's description: the main specialty and the main degree or the most recent. Authors holding more than two Ph.D degrees should mention the most recent. If affiliated with more than one University, please only mention the main affiliation.

Manuscript: Sections and subsections should be numbered (e.g. 1., 2. etc. for sections, 1.1, 1.2 for subsections).

Section titles: 14pt., lowercase, bold.

Subsection titles: 12pt., lowercase, bold.

Mathematical Formulas: mathematical formulas should appear in the body of the manuscript, please use continuous numbering on the right side of the formulas (use of math type is suggested).

Emphasis within the text can be given by using *italics*. Only use bold type in chapter titles.

Page Layout: The margins of each page should be the usual ones used in word processing software, i.e. the top and bottom margins of a A4 size page should be about 2.54 cm, while the left and right margins should be about 3.18 cm. These values are approximate.

Line spaces: Please use 1.5 spacing.

Paragraph: Please leave a blank line between the paragraphs (do not indent).

Page Numbering: The pages are numbered at the bottom center.

2. Tables – Charts

The tables and charts have a continuous numbering e.g. Table 1, Table 2 and are placed in the main body of the manuscript.

The titles of the tables and charts are set in 10pt. at the top of the table or chart with center alignment. In case there is a source, it is placed below the respective chart or table with full alignment (10pt.)

3. Footnotes

Footnote should appear at the bottom of the page, with continuous numbering for the whole manuscript (use of the automatic word processor system). Please use footnotes sparingly, using 10pt serif font.

4. References and bibliography

Please use the APA style (current edition) for citations and the list of references. If citing more authors, use a fullstop (.) and not a semi colon (;) as separator. The list of references should appear at the end of the text. Please use footnotes sparingly, using 10pt serif font.

The following are examples for the convenience of the authors.

4.1 References in text:
